We are aware that your child's safety is very important therefore with regards to safeguarding, we have put in place the following strict measures:

- These class accounts will be an exclusive locked Twitter account for verified parents/carers only and will be strictly monitored by the class teacher and senior management.
- Any other requests from other Twitter users will be instantly declined.
- Only children whose parents/carers have consented via the school's photo/social media policy will be used in tweets. This consent is taken from the GDPR document, which you should have completed previously.
